## **SERVICE CONTRACT**

Services to be rendered:

1. **Chateau Marmutt (Marmutt)** agrees to provide daycare/boarding for the animals set forth in the application, and to provide such other services as agreed to by and between the owner and Chateau **Marmutt** at the rate as agreed upon.
2. **Marmutt** shall be opened daily, except Sundays, on hours that are posted (M-F 7:30am-7:30pm Sat. 10am-5pm). In the event the owner does not pick up the animal by closing time, the owner shall pay for overnight boarding and fees.
3. In the event the owner does not pick up or arrange for the delivery of the animal by 7:30 pm, the owner shall pay **Marmutt** in addition to such other fees, \$15.00 per each fifteen minutes the owner is late after closing. If the animal has not been picked up by 7:30 p.m., or the owner has not arranged for a staff member of **Marmutt** to wait for owner to pick up animal then **Marmutt** will place animal in boarding for which owner shall be responsible and pay all fees.
4. If the owner has failed to pick up the animal by the beginning of the third day, and pay all fees and costs owing to **Marmutt**, then the animal shall be deemed abandoned and **Marmutt** may treat the animal as the property of **Marmutt**, without liability or obligation to the owner of the animal. **Marmutt** may arrange for the adoption of the animal without liability by either sale, transfer, conveyance to a third party.
5. Owner represents the dog(s) are in good health and have not been ill with any communicable diseases within the last 30 days and that the animal(s) have all current rabies, Bordatella (kennel cough) and DHLPP vaccinations and have been neutered and/or spayed. Owner further represents that the animal(s) have not been exposed to any contagious disease within the last 30 days.

6. *Marmutt* will not knowingly accept a dog that has not been spayed/neutered unless previously discussed with the owner. *Marmutt* shall not be responsible in the event a female becomes pregnant during her stay at *Marmutt*.
7. In the event the pet becomes ill or injured, *Marmutt* shall notify the owner, and if the owner cannot be contacted, or has failed to instruct *Marmutt* regarding measures to be taken, or if an emergency situation exists which requires immediate action, *Marmutt* is authorized to engage the services of a veterinarian, or to administer medicine or give such other attentive care for the animal that appears reasonably advisable.
8. *Marmutt* shall pay for any costs of the animal that may arise as a result of the injury or illness including veterinarian care and costs. The owner shall pay such costs immediately upon pick up of animal or when the service has been completed.
9. *Marmutt* reserves all rights to have any animal examined by a veterinarian of its selection if the owner of such animal placed under the care of *Marmutt* claims that the animal has become ill or injured while under such care. Any claim for an illness or injury must be reported to *Marmutt* within 48 hours since the animal was under the care of *Marmutt*. Reports for claims for illness or injury after 48 hours shall be presumed to not have occurred while under the care of *Marmutt*.
10. **Representation:** The parties understand and acknowledge that *Marmutt* has agreed to render services as described herein based upon the owners representation that the animal is healthy and has received all required shots, does not suffer from any disability, illness, behavior characteristics, or conditions which could adversely affect another pet being cared for by *Marmutt*.
11. Owner further insures *Marmutt* that the pet is not aggressive and at no time in the past has harmed or shown any aggression or threatening behavior towards any other person or any other pet and there is no history of the dog's untoward behavior as a result of being confined in an enclosed area. Notwithstanding such assurances, if the dog's behavior results in any injury to another dog, persons or property, owner shall bear full expenses resulting from such conduct. Owner agrees that *Marmutt* shall not be liable for any loss or damage to the animal by

any cause whatsoever, including a fire, theft, or escape of the animal. The owner agrees that he or she shall remain liable for any damages that the animal may cause including bites, aggressive behavior, damage to other animals. Owner assumes and understands that the pet is in an environment where other pets shall be located with other animals, and the facility shall not be liable for the damage caused to the animal by injury or other episodes, which may have been caused by or from other animals.

**12.**The animal may be isolated and kept apart from other animals, should *Marmutt* in its reasonable belief or the reasonable belief of its employees, servants or other agents determine that the animal may be in danger or may endanger other animals by virtue of its conduct, behavior or aggressive propensities. The owner of the animal understands that *Marmutt* desires to maintain the health, care and comfort of all animals within its care and to adequately provide for the safe keeping of such animals in which they have custody.

**13.**Unless agreed in writing, the owner entrusts *Marmutt* to use its best judgment in caring for the pets. Should any decision affecting the handling of the pet become necessary as a result of inclement weather or other natural causes relating to such decision, *Marmutt*, shall use reasonable judgment given the circumstances of the event or happening.

**14. Payment:** Unless other arrangements are made for payment for any service rendered to the animal at *Marmutt*, owner shall pay for services upon the pick up and/delivery of the animal.

**15.** Accounts that are charged on a monthly basis shall be due and payable by the first of each month. There is a \$5-10 monthly fee. Marmutt has permission to charge any card on file in perpetuity until bill is paid in full. Payments received by the tenth of the month shall accrue interest at the rate of 5% per month until paid.
